

6. POLICIES AND PROCEDURES

a. Food and drink

- Ideal English School offers a small dining area and a kitchen for students and staff to use:

d. Emergency Procedures


Campus security has the primary duty to respond to all medical, fire and criminal emergencies.

In an emergency use any school phone to dial 911.

According to school regulations, your tuition payments (payable every 4 weeks) are always due on the 1st, 10th or 20th of each month. You will have a 5 day "grace period" to make your payments without having to pay a late fee. There will be a \$50.00 late fee charged if your payment is 5 days overdue. If the tuition is not paid on time, you will not be able to attend classes. This is true for both part time and full-time students.







Full time students will consequently face a status termination of your I-20.

Students will be required to take the following assessments / exams throughout each term.

- Unit Quizzes
- Mid Term Exam (week 8)
- Final.Exam (week 16)

Failure to Take an Exam:

Religious Observance

Students who miss exams on certain days because of their religious beliefs will be given an opportunity to make up the exam without penalty. The attendance policy, applies to all students regardless of religious observance. Students must inform their instructors a minimum of one week prior to the religious observance day or days.

Medical excuses

Students who miss exams due to medical reasons will give an opportunity to make up the exam without penalty. Students must present documentation of medical treatment to their instructors to make up an exam.

Passing Grade

The passing grade is 70. It will be defined by the averages between mid and final terms exams.

Final Grades:

20% Average of Reading score 20% Average of listening score 20% Average of writing score 40% Average of speaking score If the student does not achieve the minimum desired grade, the academic dept. could be considerate de averages of the quizzes, or schedule an extra class in order to cover those student learning outcomes that were not met. The student will then, retake the test, in a different version.



♣ <u>Academic Probation/Failing</u>

Students who fail a course will receive academic probation for the following term. After completing a counseling session, students may repeat the level during the next term. A second failure constitutes a written academic warning followed by a counseling session with the Academic Director, and students are in danger of termination. Students receiving a third notice may be terminated. Rare instances approved or denied_on a case-by-case basis by the program's Academic Director may be deemed exemptions, for example, medical reasons.

Student Attendance

The student must obtain at least 80% attendance in classes, otherwise he/she will fail. The student can request the replacement of missing classes but will be charged.

<u>Tardiness</u>

The student must be in the classroom at the schedule time. Students who are up to 10 minutes late may enter the classroom.



8. CEFR

What is CEFR?

"Common European Frame of Reference." In short, it describes what each individual should be able to do in terms of a foreign language objectively. Furthermore, according to the speaker's degree of knowledge, it gives similar conditions to anyone, regardless of their place of origin.

Student Orientation

10. INTERNATIONAL STUDENTS IMPORTANT INFORMATION.

a. Maintaining Status


While studying in the United States, it is important to maintain your F or M student status. Your status relates to the purpose, or reason for why you want to come to the United States. The U.S. Department of State issues you your visa based on your intended purpose. If the Department of State issues you an F or M student visa, this means that you are coming to the United States to study. You should not take any action that detracts from that purpose. Maintaining your status means: Fulfilling the purpose for why the Department of State issued you your visa. Following the regulations associated with that purpose. F-1 and M-1 students share the same primary purpose for coming to the United States however, F-1 students enroll in more traditional academic programs, while M-1 students enroll in vocational programs. Because these two types of programs are different in nature, the types of benefits an international student may be eligible for and how long they may remain in the country depend on whether they are an F-1 or M-1 student. b. <u>Vacation</u>

F-1 students enrolled in an ESL program must complete at least 26 weeks of study prior to being eligible for an extended break or vacation. They must also be eligible and intend to register for study in the term following the annual vacation. The duration of an ESL student's annual vacation is equivalent to the duration of one ESL term. For example, if a school's ESL terms are six weeks long, then ESL students would have an annual vacation lasting 6 weeks. During an annual vacation, a student does not need to take classes in order to maintain nonimmigrant status. A student may take as many, few, or no courses as the student wants to. Any such study is incident to status.

c. <u>Work and Practical Training for F-1</u> <u>Students</u>

An F1 student may only work when authorized by a DSO in some cases, and U.S. Citizenship and Immigration Services (USCIS) in others.





If you choose to work without authorization, you will be forced to leave the United States immediately, and you may not be able to reenter the United States at a later date. F1 students are eligible for curricular practical training (CPT) at either the undergraduate or the graduate level during the program of study. CPT employment must be an integral part of an established curriculum and the position must directly relate to your major area of study. Your DSO can give you the school's policy on this option. F1 students are also eligible for optional practical training during or following the program of study. OPT is a form of temporary employment that directly relates to your program of study. For more information about employment and training options available for F-students, visit the Working in the United States page and talk with your DSO.

d. <u>Education</u>

While studying in the United States, both F and M students must:

Attend all your classes, and maintain normal academic progress. If school is too difficult, speak with your DSO immediately. Maintain a full course of study each term. If you cannot study full time, contact your DSO immediately. You may be eligible for a reduced course load in limited circumstances. Speak to your DSO before dropping a class. Talk to your DSO about requesting a possible program extension if you do not think you will complete your program of study by the end date listed on your Form I-20. An extension must be requested before your program end date.

e. Upon Program Completion


F and M students must take action to maintain legal status or depart the United States after completing your program of study. Once you complete your program of study and any authorized period of practical training, F students have 60 days after completion of your program (the program end date on your Form I-20) to leave the United States.

If you wish to extend your stay in the United States, talk with your DSO to learn more about doing one of the following: Transfer to another school. Change your education level (e.g., bachelor's to masters). Apply to change status to another visa status (e.g., H-1B-temporary worker; O-extraordinary ability in science, art or business; P-athlete). M students have 30 days after completion of their program (the program end date on your Form I-20) to leave the United States. The latest date you may remain in the United States is the "admit until" date on your Form I-94, "Arrival/Departure Record," unless you filed for an extension with USCIS.

f. Transferring to Another School

If you are an F or M student studying in the United States, you may be eligible to transfer to a new school. To be eligible to transfer, you must consistently maintain F or M status and follow the correct transfer procedures.

To maintain your status at your current school, you must continue attending all of your classes while you are waiting to transfer. For an F student, that is until your transfer release date. Your transfer release date is the day on which the designated school official (DSO) at your current school moves responsibility for your Student and Exchange Visitor Information System (SEVIS) record to your new school.





For an M student, that is until you have submitted an application for approval to transfer. In most cases, M students may only transfer within the first six months of their program.

If your DSO believes you may not have maintained your F or M status, your SEVIS record could be in Terminated status, which is the DSO's way of reporting a concern to the Student and Exchange Visitor Program. You may still be able to transfer in Terminated status. Talk to your current DSO and a DSO at the new school if you want to transfer with a terminated record.

If you have employment authorization and are in the process of transferring to a new school, talk to your current DSO about how your transfer will affect your employment authorization. You may continue authorized work at your current school until the transfer release date in SEVIS, but all work authorization ends after that date. After you transfer to your new school, talk to your DSO about employment options at that school.

11. SAFETY AND HEALTH

Health Insurance

IES does not require any type of health insurance for language students; however, it is highly recommended. Failure to obtain health insurance coverage can be very expensive in case of illness, accident or injury.

Health insurance is very important in the United States, and we strongly suggest that our students are covered to avoid the high cost of an accident or injury. Medical costs can be extremely high. We recommend that you contact one of the following providers to obtain health insurance:
